One Day Workshop on Prevention of Sexual Harassment at Workplace

Date: 28/7/2017

As part of VPIMSR, Sangli's endeavor of ensuring a safe, secure and gender neutral campus, the Institute organized a training workshop on 'Prevention of Sexual Harassment at Workplace' on 28/7/2017. The session was conducted by Adv. Mukta Madansingh Dube , Practitioner in Sangli- Miraj court is the expert believes that —the sexual harassment at workplace does not only cause mental and/or physical damage to the person harassed; but also seriously curtails opportunities at work by creating a discriminatory work environment. The session covered aspects related to hearing and addressing complaints regarding sexual harassment and spreading awareness about gender-related issues and functioning of the Internal Complaints Committee.

The session began with welcome address by Dr. R.A. Shinde, Principal of the institute. Dr. N.U. Deshpande , Advocate(Chairman of Internal Complaint Committee) started her talk by an activity which explained the difference between 'good touch' and 'bad touch' and explained how a person's body language plays an important role in understanding what he or she feels. Discussing about various forms of sexual harassment (verbal, physical, visual), Dr. N. U. Deshpande said that silence doesn't always mean that any act is welcome; and encouraging some behaviour doesn't mean that any kind of behaviour is welcome. She also discussed how many women do not complain or report due to fear of retaliation, social stigma, lack of evidence, fear of loss of reputation, low self-confidence, fear of job loss or lack of awareness. Explaining the importance of Internal Committee in every organization, Dr. N. U. Deshpande talked about Sexual Harassment of Women at Workplace Act, 2013 and discussed the Internal Committee and its working .

Adv. Mukta Madansingh Dube then discussed about the three major laws in context to sexual harassment namely, Indian Penal Code, Criminal Procedures Code and Information Technology Act. She also gave suitable examples and explained the difference between workplace harassment and sexual harassment and the process of filing complaints at Police Stations. The session concluded with details of how any organization can take preventive measures against sexual harassment.

The workshop was held in two sessions for the entire students of all classes and staff of the Institute. Certificates were distributed to all the participants.

One Day Workshop on Prevention of Sexual Harassment at Workplace

Date: 8th March 2018

As part of VPIMSR, Sangli's endeavor of ensuring a safe, secure and gender neutral campus, the Institute organized a training workshop on 'Prevention of Sexual Harassment at Workplace' on8th March 2018. The session was conducted by Adv. Jayashree Pendase and Radha Sawant, Women Entrepreneur & Social worker. The session covered aspects related to hearing and addressing complaints regarding sexual harassment and spreading awareness about gender-related issues and functioning of the Internal Complaints Committee.

Report on

One Day Workshop on Prevention of Sexual Harassment at Workplace'

Date: 23rd Sept. 2019

As part of VPIMSR, Sangli's endeavor of ensuring a safe, secure and gender neutral campus, the Institute organized a training workshop on 'Prevention of Sexual Harassment at Workplace' on March 2015. The session was conducted by Adv. Jayashree Pendase and dv. N.U. Deshpande, chairman of ICC. Both of the experts think that an organization that believes that sexual harassment at workplace does not only cause mental and/or physical damage to the person harassed; but also seriously curtails opportunities at work by creating a discriminatory work environment. The session covered aspects related to hearing and addressing complaints regarding sexual harassment and spreading awareness about gender-related issues and functioning of the Internal Complaints Committee.



The session began with welcome address by Dr. R.A. Shinde, Principal of the institute. N.U. Deshpande, Advocate started her talk by an activity which explained the difference between 'good touch' and 'bad touch' and explained how a person's body language plays an important role in understanding what he or she feels. Discussing about various forms of sexual harassment (verbal, physical, visual), Dr. N. U. Deshpande said that silence doesn't always mean that any act is welcome; and encouraging some behavior doesn't mean that any kind of behavior is welcome. She also discussed how many women do not complain or report due to fear of retaliation, social stigma, lack of evidence, fear of loss of reputation, low self-confidence, fear of job loss or lack of awareness. Explaining the importance of Internal Committee in every organization, Dr. N. U. Deshpande talked about Sexual Harassment of Women at Workplace Act, 2013 and discussed the timelines and Pit Stops for Internal Committee and how the Internal Committee works.









Adv. Jayashree Pendase then discussed about the three major laws in context to sexual harassment namely, Indian Penal Code, Criminal Procedures Code and Information Technology Act. She also gave suitable examples and explained the difference between workplace harassment and sexual harassment and the process of filing complaints at Police Stations. The session concluded with details of how any organization can take preventive measures against sexual harassment.

The workshop was held in two sessions for the entire students, Administrative supportive staff and security and housekeeping staff of the Institute.

She said before the law and legislature come into existence there is history of struggle behind it. In 1974 Abortion Act and dowry act came into exist.

She explained about the law of Vishakha Guidelines. Since 2013 the prevention and prohibition act in order to prevent sexual harassment has come out very strongly. She explained the definition of Sexual Harassment and covered many points. She has stated that the sexual harassment includes unwelcome sexually determined behavior as physical contact, demand or request for sexual favors, sexually coloured remarks, showing pornography, any other unwanted physical, verbal or nonverbal conduct of sexual nature the unwelcome idle chatter of sexual nature, verbal or non-verbal conduct of a sexual nature. Also introduced Guidelines, complaint mechanism, what are the preventive steps, employer's responsibilities. She also explained the definition of employees and what is workplace. She also mentioned that "No witness does not mean false complaints." At the end, many students asked doubts to guest speakers. Dr. N U Deshpande and guest speakers cleared their doubts.
